#### **Who processes your personal data?**

Your personal data are processed by operator – company ProCare, a.s., Einsteinova 23-25, 851 01 Bratislava, company ID: 35 890 568 (hereinafter the „**Operator**“).

You can contact the person responsible for personal data processing and supervising proper personal data processing at any time on e-mail address [dpo@procare.sk](mailto:dpo@procare.sk)

#### **What personal data of you are processed by us?**

The Operator processes the following data of you in electronic and documentary form: name, surname, contact data, sex, age, purchased products and services in the past, and terms of appointments to examinations.

#### **What is the purpose and legal basis of your personal data processing by the Operator?**

The operator processes your personal data within required extent on basis of consent conferred by you, if applicable.

Consent conferred for the stated purposes is voluntary but required if you want to be contacted by us with product and service offers of ProCare Group. Your voluntary consent clearly confirmed with your signature can be withdrawn at any time in written form delivered to the Operator's registered office.

#### **Will your personal data be provided to other recipients?**

Your personal data can be provided to other companies within ProCare Group, especially to companies included in the ProCare Network pursuant to General Contract Terms of company ProCare, a.s., Einsteinova 23-25, 851 01 Bratislava, company ID: 35 890 568 for purpose of personal management services associated with healthcare provision aimed at ensuring your appointments to healthcare provision at healthcare facility of ProCare Network, which shall process your personal data as a mediator; to IT service providers, attorneys in law, auditors, archive and further persons that provide services to the Provider and who the Provider concluded contract with on personal data processing.

#### **Will your personal data be transferred to third countries?**

We don't intend to transfer your personal data to third countries.

#### **How long will your personal data be processed for the intended purpose?**

If the Provider processes your personal data on basis of your conferred consent, your personal data shall be processed by him within the consent validity or until the consent withdrawal.

Processing personal data, the Provider applies the principle of minimizing, i.e. your personal data shall become anonymous in the databases and IS upon lapsed period of obligatory personal data storage. ProCare Group has set forth strict internal principles of personal data storage, ensuring that the data are not stored longer than for period that the Operator is obliged or authorized to.

#### **What are your rights associated with personal data processing?**

Based on your written request, you have right to (i) require access to your personal data, (ii) require correction of your personal data, (iii) require deletion of your personal data, (iv) require restricted personal data processing, (v) raise objection against personal data processing, (vi) require transfer of your personal data, and (vii) file complaint at Personal Data Protection Office, Hraničná 12, Bratislava.

**Is your personal data processing associated with automated decision making including profiling?**

Your personal data processing is not associated with automated decision making including profiling.
