

## **Information on the processing of personal data Registration in the application**

The proper processing of personal data is very important to us, and their protection is a matter of course for us. Therefore, we would like to provide you with information regarding the processing of personal data. ### **Who processes personal data?**

Personal data is processed by ProCare, a.s., Einsteinova 23-25, 851 01 Bratislava, Company Registration Number 35 890 568 as the operator (**hereinafter referred to as the "Operator"**). You can contact the person responsible for the protection of personal data supervising their proper processing at any time by e-mail at [dpo@procare.sk](mailto:dpo@procare.sk)

### **What personal data do we process?**

For the purposes listed below, the Operator processes ordinary personal data.

### **What are the purposes and legal basis for processing personal data by the Operator?**

The Operator processes personal data to the necessary extent:

1. to create and subsequently maintain the registration of your user profile in this application; the legal basis for this purpose is the

legitimate interest of the Operator following Article 6 par. 1 letter f) GDPR, whereas the legitimate interest of the Operator consists in improving the quality of service for clients and in simplifying the administration when dealing with their requests;

2. to prepare the agreement for the provision of services and management in the provision of healthcare including related documentation if you are not yet our client; the legal basis for this purpose is Article 6 par. 1 letter b) Regulation (EU) 2016/679 of the European Parliament and the Council on the protection of natural persons concerning the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation - GDPR);

3. to link the profile created by you in the application with the existing profile in the Workflow information system; the legal basis for this purpose is the legitimate interest of the Operator following Article 6 par. 1 letter f) GDPR, whereas the legitimate interest of the Operator consists in improving the quality of service for clients and in simplifying the administration when dealing with their requests. For these purposes, the provision of personal data is completely voluntary but necessary to fulfill the stated purposes. Without providing this data, we would not be able to achieve the stated purposes.

### **Will personal data be provided to other recipients?**

Personal data concerning registration in the application may be provided to third parties only if necessary, whereas the third party can be, for example, a supplier of IT services or public authorities of the Slovak Republic, or entities who entered into a contract on the processing of personal data following Article 28 of the GDPR with the Operator, or persons who are authorized to process personal data under applicable law.

### **Will personal data be transferred to third countries?**

The transfer of personal data to third countries is not intended.

### **How long are personal data processed for the above purposes?**

Personal data shall be stored by the Operator for the duration of your contractual relationship with the Operator and after its termination until the settlement of all obligations arising from or related to it, or until the Operator's legitimate interest in their processing ceases. When dealing with personal data, the Operator applies the principle of minimization, which means that personal data are anonymized from databases and information systems as soon as the period during which the Operator is obliged to store personal data expires.

### **What are your rights in connection with the processing of personal data?**

Based on a written request, you shall be entitled to (i) request access to personal data, (ii) request correction of personal data, (iii) request deletion of personal data, (iv) request restriction of processing, (v) object to processing, (vi) request the transfer of personal data and (vii) file a complaint at the Office for Personal Data Protection of the Slovak Republic, Hraničná 12, Bratislava. Other rights may result from special generally binding legal regulations.

### **Does the processing of personal data involve automated decision-making, including profiling?**

When processing personal data, there is no automated decision-making, including profiling.
